#### SECTION 4 : FIRST AID MEASURES

##### 4.1 DESCRIPTION OF FIRST-AID MEASURES:



Symptoms may occur after exposure, so that in case of direct exposure to the product, when in doubt, or when symptoms persist, seek medical attention. #### SECTION 5 : FIRE-FIGHTING MEASURES

##### 5.1 EXTINGUISHING MEDIA:

Extinguishing powder or CO<sub>2</sub>. In the case of more important fires, also alcohol resistant foam and water spray/mist. Do not use for extinguishing: direct water jet. Direct water jet may not be effective to extinguish the fire, since the fire may spread.

##### 5.2 SPECIAL HAZARDS ARISING FROM THE SUBSTANCE OR MIXTURE:

Decomposes when heated intensely. Fire can produce a dense black smoke. As consequence of combustion or thermal decomposition, hazardous products may be produced: carbon monoxide, carbon dioxide. Harmful. Irritant. Exposure to combustion or decomposition products may be a hazard to health.

##### 5.3 ADVICE FOR FIREFIGHTERS:

Special protective equipment: Depending on magnitude of fire, heat-proof protective clothing may be required, appropriate independent breathing apparatus, gloves, protective glasses or face masks and boots. If the fire-proof protective equipment is not available or is not being used, combat fire from a sheltered position or from a safe distance. EXPOSURE CONTROLS:

ENGINEERING MEASURES:



Provide adequate ventilation. Where reasonably practicable, this should be achieved by the use of local exhaust ventilation and good general extraction. If these measures are not sufficient to maintain concentrations of particulates and vapours below the Occupational Exposure Limits, suitable respiratory protection must be worn.

Protection of respiratory system: Avoid the inhalation of vapours.

Protection of eyes and face: It is recommended to install water taps or sources with clean water close to the working area.

Protection of hands and skin: It is recommended to install water taps or sources with clean water close to the working area. Barrier creams may help to protect the exposed areas of the skin. Barrier creams should not be applied once exposure has occurred.

OCCUPATIONAL EXPOSURE CONTROLS: Regulation (EU) No. 2016/425:

As a general measure on prevention and safety in the work place, we recommend the use of a basic personal protection equipment (PPE), with the corresponding EC marking.
